It is the person who makes it possible to start the day and to go to bed at night. It is also the person who enables the individual to participate in a quality of life within the world. This person does not just help their client with the basic physical and medical needs, but provides them with a caring, understanding, compassionate, stable relationship that enhances the dignity, integrity and total well-being of the person with disabilities they serve. The Direct Support Professional must live or work in Lafourche Parish.**

### **Criteria for the 2010 Outstanding Direct Support Professional**

- **Respect for the client's daily choices and life choices**
- **Dependability and punctuality**
- **Attention to the appearance and grooming of client and self**
- **Participation in activities at home and in the community**
- **Quality and variety of activities in which the client is engaged**
- **Individual with disabilities' testimony on the quality of life due to the Direct Support Professional's involvement**

- **Both owner and service animal have demonstrated perseverance in facing barriers**
